



LawCite Help Guide/Overview

LawCite is one of the features of SAFLII's online research facility and is an immensely helpful tool for legal practitioners, as well as researchers and students of law. It is an automatically-generated database that allows you to see all the instances where a certain case has been referred to and discussed in other cases, in law reform reports and in journal articles (both locally and abroad). It also shows all of the other cases, legislation and articles that were cited in the case itself. Thus, LawCite allows you to see a picture of all the connections that the case has to the rest of South African jurisprudence, as well as foreign jurisprudence, which can be essential when you want to use the case as legal authority.

LawCite can also be used in relation to law journal articles contained in SAFLII's databases. It shows a complete record of the cases, law reform reports, and other law journal articles that refer to an article, as well as the legislation, cases and other articles referred to in the article itself.

LawCite is a project of [AustLII](#) in collaboration with other legal information institutes (LIIs) across the globe that are members of the [Free Access to Law Movement](#). It is updated automatically on a continuous basis and, like all the other features of SAFLII, LawCite is free to access for private use.

Using LawCite to research a resource

To see how a resource is connected to other legal resources, simply click the LawCite link at the top of the case/journal article to access the LawCite record.


