## ROAD CARRIER PERMITS

Swart bridge to places situated within Namibia and to a place on the Namibia/Republic of South Africa border at Nakop or Noordoewer and return subject to the condition that the persons who are being conveyed on the return journey were also conveyed on the forward journey.
- 2. A group of persons who are travelling together to jointly attend a religious gathering or to jointly attend a picnic, concert or other form of amusement or to jointly participate in any competition or game as well as their personal luggage - From Kalkfeld, Karibib, Okahandja, Omaruru, Otjiwarongo, Swakopmund, Usakos and Windhoek as well as from a place on the



Namibia/Republic of South Africa border South of Swakopmund at the C.R. Swart bridge to places situated within Namibia and to a place on the Namibia/Republic of South Africa border at Nakop or Noordoewer and return subject to the condition that the persons who are being conveyed on the return journey were also conveyed on the forward journey and subject to the further condition that the return journey be commenced, within 36 (thirty six) hours, after completion of the relative forward journey.

3. 5. Pupils or students as well as their personal luggage at the closing of schools, colleges or universities for holidays subject to the condition that no pupils and/or scholars studying at Paarl, Wellington, Stellenbosch or Cape Town who has Keetmanshoop and/or Mariental as destination may be conveyed - From a place on the Namibia/Republic of South Africa border at Nakop or Noordoewer to places situated within Namibia.
6. Fresh meat for use by anglers who are going angling and who are being conveyed in the bus set out in the public road carrier permit to which this annexure relates - From Windhoek to Henties Bay, Swakopmund and/or a place on the Namibia/Republic of South Africa border South of Swakopmund at the C.R. Swart bridge.
7. Fresh fish belonging to and/or caught by anglers who are being conveyed in the bus set out in the public road carrier permit to which this annexure relates - From a place on the Namibia/Republic of South Africa border South of Swakopmund at the C.R. Swart bridge, Henties Bay and/or

Swakopmund to Windhoek.

8. Organised air-traffic passengers (exclusively boat crews) - From Windhoek International Airport or Windhoek to Walvis Bay via Okahandja, Karibib, Usakos and Swakopmund and return via the same route.
9. Pupils and their personal luggage at the closing or reopening of schools including during out weekends - From and to Windhoek to and from Gobabis.
10. A group of persons who are travelling together for educational purposes or who are travelling together to jointly attend a religious gathering or to jointly attend a picnic, concert or other form of amusement or to jointly participate in any competition or game as well as their supervisors and personal luggage - From Windhoek, Okahandja, Usakos, Karibib, Omaruru, Kalkfeld, Windhoek, Otjiwarongo, Swakopmund and a place situated on the Republic of Namibia/Republic of South Africa border at Noordoewer or Nakop or from a place on the Republic of Namibia/Republic of Botswana border at Ngoma to places situated within the Republic of Namibia and return subject to the conditions that:
  - (a) the same persons be conveyed on both the forward and return journey, and;
  - (b) the return journey be commenced within 36 (thirty six) hours after completion of the forward journey and further that the persons conveyed on the return journey were also conveyed on the forward journey.
11. - (a) The conveyance should only be undertaken on request and conclude a valid agreement with a tourist guide and/or tourist party;
- (b) No tickets should be sold on the way;
- (c) the persons being conveyed on the return journey were also conveyed on the forward journey except for the provision that was made in paragraph (D);
- (d) the persons may only interrupt the journey if they intend to join another tourist party with whom they are going to finish the trip.
