**CHANGE OF BOUNDARIES OF CERTAIN REGIONS:
REGIONAL COUNCILS ACT, 1992**

In terms of section 5(3)(b) of the Regional Councils Act 1992 (Act No. 22 of 1992) and pursuant to the report of The Second Delimitation Commission on Determination of Regions and Constituencies, dated 3 August 1998, which has been accepted by me, I hereby make known that -

- (a) the boundaries of the following Regions as described in Proclamation No. 6 of 1992, have changed, namely,
- Region No. 1: Kunene Region
 - Region No. 2: Omusati Region
 - Region No. 3: Oshana Region
 - Region No. 5: Oshikoto Region
 - Region No. 6: Okavango Region
 - Region No. 7: Caprivi Region; and
- (b) the name of the "Okavango Region" has changed to "Kavango Region".

The definition of the new boundaries of the regions referred to in paragraph (a) above are as set out in the amendments effected to the First Schedule to Proclamation No. 6 of 1992 by the Schedule to this Proclamation.

SCHEDULE

The First Schedule to Proclamation No. 6 of 3 March 1992 is amended as set out in this Schedule:

1. The following paragraph is substituted for the paragraph titled "REGION NO 1: KUNENE REGION" contained in that First Schedule :

"REGION NO. 1 : KUNENE REGION comprising the area bounded as follows :

Beginning in the middle of the mouth of the Kunene River upstream along the middle of the said river in a general easterly direction to a point with system 22/15 approximate co-ordinate X -508 000, thence in grid direction 270°00'00" to the Ruacana Rest Camp at approximate co-ordinates Y +83 000 and X -508 000, excluding the rest camp from the region , thence in a southerly, south-westerly, southerly, south-easterly, southerly and south-westerly direction along the middle of a road to the Ombarandu Border check point, at approximate co-ordinates Y +90 600 and X -461 700, to include Ombarandu in the region, thence in a general south-easterly direction for approximately 33 kilometres along the middle of a road to the Ombombo Border check point at approximate co-ordinates Y +76 000 and X -442 000, thence in a southerly direction along the middle of the Ruacana-Kamanjab main road to the north-eastern corner beacon of the farm Kowares 276 to include the said farm in the region, thence in a general southerly, easterly, northerly, westerly, northerly, easterly, southerly and easterly direction along the western and southern boundaries of the Etosha National Park, to the north-eastern corner beacon of the farm Monty 329, thence in a general southerly direction along the boundaries of the following farms in succession so as to include these farms in the region; Monty 329, Spaatzhu 761, Zhukov Oos 762, Michael 347, Elf 361, Nissen 357 and Klein Huis 174,

to the easternmost corner beacon of the last-mentioned farm; thence in a south-westerly direction along the boundaries of the following farms in succession so as to exclude these farms from the region; Belvedere 198, Goedbegin 197, Fresnaye 196, Homestead 205, Wembley 203, Jobos 169, Summerdown 168, Arcadia 320, Naribis 166, Rusthof 353, Bobbejaankrans 350, Schartzenfels 33, Karolsbrunn 35, Garfield 36, Ohange 421, Groenboom 37, Otjitoroa 56, Otjitoroa West 57, Otjisauna 58, Omakend Nord 59, Elim 92, Farm 696, Elim 92 and Hagenhof 91, to the westernmost corner beacon of the last-mentioned farm, thence in a north-westerly direction along the boundaries of the following farms in succession so as to include these farms in the region; Kabussemjama 90, Madagascar 89, Ehorongue 85, Omburo Ost 81, Omburo West 82 and Farm 84, to a point on the southern boundary of the last-mentioned farm intersects with the Ugab River, thence downstream along the middle of the said river, to the mouth of the said river; thence along the line of the coast in a general north-westerly direction to the point of beginning.”.

2. The following paragraph is substituted for the paragraph titled “REGION NO. 2: OMUSATI REGION” contained in that First Schedule :

“REGION NO. 2 : OMUSATI REGION comprising the area bounded as follows:

Beginning at Boundary Beacon 1 on the Namibia/Angola border, in a general easterly direction along the said border to a point where it intersects the middle of the Shakambebes Oshana; thence in a general southerly direction along the middle of the said Oshana to a point with system 22/15 co-ordinates Y -69 500 and X -479 000, thence in a general south-westerly direction in a straight line to a point where the middle of the Etaka Oshana intersects the line of latitude 18°02'00" S, thence in a general south-easterly direction along the middle of the last-mentioned Oshana to a point where the line of latitude 18°09'00" S intersects with line of longitude 15°30'00" E, thence in a southerly direction in straight line to a point where line of latitude 18°39'00" S intersects with line of longitude 15°34'00" E on the northern boundary of the Etosha National Park, thence in a general westerly direction along the said boundary to a point in the middle of a road at approximate co-ordinates Y-57 000 and X-368 000; thence in a general south-westerly direction along middle of the said road to a T-junction at approximate co-ordinate X-358 500; thence along the middle of the fork in a general south-easterly, southerly and south-westerly direction to a T-junction at approximate co-ordinate X-331 400; thence in a south-easterly direction along the middle at the Otjovasandu-Okaukuejo road to a T-junction at approximate co-ordinate Y-63 500; thence along the middle of the fork in a general westerly direction to a T-junction at approximate co-ordinate Y-33 500; thence in a general southerly direction along the middle of the fork to the north-eastern corner beacon of the farm Safari 663; thence in a westerly, southerly, easterly, southerly, westerly and northerly direction along the southern and western boundaries of the Etosha National Park, thence in a general northerly direction along middle of Ruacana-Kamanjab main road to the north-eastern corner beacon of the Kowares 276 to exclude the said farm from the region; thence along the middle of the said road to the Ombombo Border check point at approximate co-ordinates Y+76 000 and X-442 000; thence in a general north-westerly direction along a road for approximately 33 kilometres to the Ombarandu Border check point at approximate co-ordinates Y+90 600 and X-

46 1700; thence along the middle of a road in a north-easterly, northerly, north-westerly, northerly, north-easterly and northerly direction to the Ruacana Rest Camp at approximate co-ordinates Y+83 000 and X-508 000; thence in grid direction 90°0'00" to a point in the middle of the Kunene River at co-ordinate X -508 000; thence in a northerly direction along the middle of the said river to the point of beginning."

3. The following paragraph is substituted for the paragraph titled "REGION NO. 3: OSHANA REGION" contained in that First Schedule :

"REGION NO. 3 : OSHANA REGION comprising the area bounded as follows :

Beginning at a point in the middle of the Shakambebe Oshana with system 22/15 co-ordinate Y -69 500 and X -479 000, thence in a general easterly direction in a straight line to a point where the line of latitude 17°41'20" S intersects the line of longitude 16°00'00" E; thence in a southerly direction in a straight line to the south-eastern corner beacon of the farm Ondangwa Town and Townlands 882; thence in a southerly direction in a straight line to a point where the line of latitude 18°01'00" S intersects the line of longitude 16°00'00" E in the middle of a road running in a south-western to north-eastern direction; thence in a general north-easterly direction along the middle of the said road for approximately 2 kilometres to a point where it intersects a road running in a northern to southern direction at the intersection of line of latitude 18°01'10" S and the line of longitude 16°00'45" E, thence in a general southerly direction along the middle of the last-mentioned road to the trigonometrical beacon Okaruku No. 156 at the intersection of line of latitude 18°13'20" S and the line of longitude 16°01'30" E; thence in a general south-westerly along the middle of the said road to a point where the line of latitude 18°18'30" S intersects the line of longitude 15°57'00"E; thence in a general southerly direction in the middle of the said road to a point where with co-ordinates Y -101 350 and X -400 000, thence in a westerly direction along in a straight line to a point where with co-ordinate X -400 000 in the middle of the Ekuma Oshana; thence in a general southerly direction along the middle of the said Oshana to a point where it drains into the Etosha Pan with system 22/17 at approximate co-ordinate Y+102 500; thence in a south-westerly, southerly and south-easterly direction along the western edge of the Etosha Pan to its intersection with a road with system 22/15 at approximate co-ordinate Y-102 200; thence in a southerly direction along the middle of the said road, until its intersection with the Halali-Okaukuejo main road; thence in a westerly direction along the middle of the last-mentioned road, including Okaukuejo into the region; thence in a southerly direction along the middle of the Okaukuejo-Outjo main road until its intersection with the southern boundary of the Etosha National Park; thence westwards and northwards along the southern boundary of the said Park up to the north-eastern corner beacon at the Farm Safari 663; thence in a northerly direction along a road to a T-junction with approximate co-ordinate Y-33 500; thence in a easterly direction along the fork to a T-junction with the Otjovasandu-Okaukuejo road with approximate co-ordinate Y -63 500; thence in a north-westerly direction along the fork to a T-junction with co-ordinate X-331 400; thence in a north-easterly, northerly and north-westerly direction to a T-junction with approximate co-ordinate X-358 500; thence in a general northerly direction along the fork to a point on the northern boundary of the Etosha National Park with co-ordinates Y -57 000 and X -368 000, thence in a general easterly

direction along the said boundary to a point where line of latitude 18°39'00" S intersects with line of longitude 15°34'00" E, thence in a general northerly direction in a straight line to point where line of latitude 18°09'00" S intersects with line of longitude 15°30'00" E in the middle of the Etaka Oshana; thence in a general north-westerly direction along the middle of the said Oshana to a point where it intersects the line of latitude 18°02'00" S, thence in a general north-easterly direction in a straight line to the point of beginning."

4. The following paragraph is substituted for the paragraph titled "REGION NO. 5: OSHIKOTO REGION" contained in that First Schedule :

"REGION NO. 5 : OSHIKOTO REGION comprising the area bounded as follows:

Beginning at a point where line of latitude 17°41'20" S intersects line of longitude 16°00'00" E; thence in a general south-easterly direction in a straight line to a point where line of latitude 17°56'00" S intersects line of longitude 16°22'00" E; thence in a general north-easterly direction in a straight line to a point where line of latitude 17°46'00" S intersects line of longitude 16°45'20" E; thence in an easterly direction in a straight line to a point where line of latitude 17°45'00" S intersects line of longitude 18°00'00" E; thence in a southerly direction along the said line of longitude to a point where it intersects the northern boundary of the farm Last Hope 880; thence in a easterly direction along the northern boundaries of the following farms in succession so as to include these farms in the region; Last Hope 880, Wildernis 882, Randeier 1062 and Farm 1061 to the north-eastern corner beacon of the last-mentioned farm, thence in a general southerly direction along boundaries of the following farms so as to include these farms in the region; Farm 1061, Driehoek 883, Choantsas 292, Gaob 760, Kliprand 827, The Pennys 826, Bethanie 837, Cork 696, Cuxhaven 697, Brisbane 674, Buenos 675, Boston 671, Bremen 672, Bergen 668, Batavia 667, Castries 680, Chicago 682, and Nosib Block III 655, to the south-eastern corner beacon of the last-mentioned farm; thence in a general westerly direction along the boundaries of the following farm in succession so as to include these farms in the region; Nosib Block III 655, Ghaub 47, Ghaub West 590, Mosbach 48, Walroda 546, Neuhorst Nord 475, Vogelberg 462, Wandelberg 462, Seringboom 460, Guinas Weide 456, Guinas Vlei 1126, Portion 1 of Guinas 454, Guinas Vlei 1126, Portion 2 of Guinas 454, Farm 843, Ventersville 855, Kroonhof 1064 and Heliodor 857 to the south-western corner beacon of the last-mentioned farms; thence in a south-westerly and westerly direction along the eastern and southern boundaries of the Etosha National Park until its intersection with the Okuakuejo-Outjo main road; thence in a northerly direction along the middle of the said main road, to exclude Okuakuejo from this region; thence in a easterly direction along the middle of the Halali-Okuakuejo main road to a T-junction with system 22/15 co-ordinate Y -100 400; thence in a northerly direction along the middle of the fork to its intersection with the Etosha Pan at approximate co-ordinate Y-102200; thence in a north-westerly, northerly and north-easterly direction to a point with system 22/17 approximate co-ordinate Y+100000; where the Ekuma Oshana drains into the Etosha Pan; thence in a northerly direction upstream with the middle of the said Oshana to its intersection with a point with system 22/15 co-ordinate X -400 000; thence in an easterly direction in a straight line to a point in the middle of road running in northern and southern direction with co-ordinates Y

–101 350 and X –400 000; thence in a general northerly direction along the middle of the said road; to a point where line of latitude 18°18'30" S intersects line of longitude 15°57'00" E; thence in a general north-easterly direction along the middle of the said road to the trigonometrical beacon Okaruku No. 156 at the intersection of line of latitude 18°13'20" S and line of longitude 16°01'30" E; thence in a general northerly direction along the of the said road to a point where it intersects the middle of a road running in a south-western and north-eastern direction at the intersection of line of latitude 18°01'10" S and the line of longitude 16°00'45" E; thence in a general south-westerly direction along the middle of the last-mentioned road for approximately 2 kilometres to a point where latitude 18°01'00" S intersects line of longitude 16°00'00" E; thence in a northerly direction in a straight line to the south-eastern corner beacon of the farm Ondangwa Town and Townlands 882; thence in a northerly direction along the boundary of and excluding the said farm to the north-eastern corner beacon of that farm; thence in a northerly direction in a straight line to the point of beginning.”.

5. The following paragraph is substituted for the paragraph titled “REGION NO. 6: OKAVANGO REGION comprising” contained in that First Schedule :

“REGION NO. 6 : KAVANGO REGION comprising the area bounded as follows:

Beginning at a point where the Namibia/Angola border is intersected by line of longitude 18°00'00" E in an easterly direction along the said border until the middle of the Kavango River is reached, thence downstream along the middle of the said river in a general south-easterly, easterly and south-easterly direction to Dikuyu Island, thence in a general easterly direction along the straight line Namibia/Angola border until its intersection with the line of longitude 22°30'00" E, thence in a southerly direction along the said line of longitude until its intersection with the straight line Namibia/Botswana border, thence in a general westerly direction along the last-mentioned border until the “corner” in the Namibia/Botswana border, thence in a southerly direction along the same border until its intersection with line of latitude 19°10'00" S, thence in a westerly direction along the line of latitude until its intersection with the eastern boundary of the farm Talitha 1006, thence in a northerly direction along the eastern boundaries of the following farms in succession so as to exclude these farms from the region; Talitha 1006, Hero 1007, Verskyn 1019, Farm 1013, Wildgrund 1018 and Wildhagen 1019, to the north-eastern corner beacon of the last-mentioned farm, thence in a general westerly direction along the northern boundaries of the following farms in succession so as to exclude these farms from the region, Wildhagen 1019, Farm 1020, Farm 1021, Farm 1022, Na-Oes 1027, Farm 1028, Tranedal 1033, Farm 1034, Farm 1039, Farm 1040, Wag-‘n-Bietjie 1046, Farm 1047, Farm 1052, Stilte 1053, Farm 1058, Farm 1059, Farm 1061, Randeier 1062, Wildernis 882 and Last Hope 880 to a point where the northern boundary of the last-mentioned farm intersects the line of longitude 18°00'00" E, thence in a northerly direction along the line of longitude to the point of beginning.”.

6. The following paragraph is substituted for the paragraph titled “REGION NO. 7: CAPRIVI REGION comprising” contained in that First Schedule :

“REGION NO. 7 : CAPRIVI REGION comprising the area bounded as follows:

Beginning at a point where the line of longitude 22°30'00" E intersects the straight line Namibia/Angola border, thence in a general easterly direction along the said border to the middle of the Kwando River; thence in a general easterly direction along the straight line Namibia/Zambia border to the middle of the main channel of the Zambezi River downstream to a point where it intersects with the Chobe River, thence upstream along the middle of the Chobe River, i.e. along the Namibia/ Botswana border, in a general westerly, south-westerly and north-westerly direction until it meets the Liambezi Lake, thence upstream along the middle of the Chobe/Linyandi/Mashi River in a general south-westerly and north-westerly direction until the straight line Namibia/Botswana border is met, thence along the said border in a general westerly direction to its intersection with the line of longitude 22°30'00" E, thence in a northerly direction along the said line of longitude to the point of beginning.”.

RE-DIVISION OF CERTAIN REGIONS INTO CONSTITUENCIES:
REGIONAL COUNCILS ACT, 1992

In terms of section 5(3)(b) of the Regional Councils Act 1992 (Act No. 22 of 1992) and pursuant to the report of The Second Delimitation Commission on Determination of Regions and Constituencies, dated 3 August 1998, which has been accepted by me, I hereby make known that a re-division has been made of constituencies of the different Regions, excluding the Karas Region, as described in the Schedule to Proclamation No. 25 of 1 September 1992.

The re-division of the regions concerned and the boundaries and names of the constituencies concerned are as set out in the amendments effected to the Schedule to Proclamation No. 25 of 1992 by the Schedule to this Proclamation.

SCHEDULE

The Schedule to Proclamation No. 25 of 1 September 1992 is amended as set out in this Proclamation.

1. The paragraph “REGION NO. 1 : KUNENE REGION” is amended -
 - (a) by the substitution for the paragraph “*Ruacana Constituency*” of the following paragraph :

"Epupa Constituency"

Beginning in the middle of the mouth of the Kunene River upstream along the middle of that river in a general easterly direction to a point with system 22/15 approximate co-ordinate X -508 000, thence in grid direction 270°00'00" to the Ruacana Rest Camp at approximate co-ordinates Y +83 000 and X -508 000, excluding the rest camp from the constituency, thence in a southerly, south-westerly, southerly, south-easterly, southerly and south-westerly direction along the middle of a road to the Ombarandu Border check point, at approximate co-ordinates Y +90 600 and X -461 700, to include Ombarandu in the constituency, thence in a general south-easterly direction for approximately 33 kilometres along the middle of a road to the Ombombo Border check point at approximate co-ordinates Y +76 000 and X -442 000, thence in a westerly direction along the line of latitude 18°S to the Atlantic Ocean; thence along the line of the coast in a general northerly direction to the starting point."

- (b) by the substitution for the paragraph "*Opuwo Constituency*" of the following paragraph :

"Opuwo Constituency"

This Constituency is bounded by line of latitude 18°S from the coast eastwards to the point where the line of latitude 18°S crosses the Ruacana/Kamanjab Road; thence in a southerly direction along the Ruacana/Kamanjab Road to the point where that Road crosses the line of latitude 19°S; thence along the last-mentioned line of latitude westwards to the coast; thence along the line of the coast running in a general north-westerly direction to the starting point."

- (c) by the substitution for the paragraph "*Kamanjab Constituency*" of the following paragraph :

"Kamanjab Constituency"

Beginning at the most north-westerly point of the farm Ermo 646; thence in a general easterly direction along the southern boundary of the Etosha National Park to the most north-easterly boundary of farm Leeupoort 441; thence in a southerly direction along the easterly boundaries of farms Leepoort 441, Excelsior 442, Vergenoeg 440, Farm 447, Otjovasando, Tzonaas 218, Tzaus 225, Aimab 124, Borwa 123, Luisental 114, Neuland 541, Dornfeld 135, Deurslag 136, Klein Ombura 148, to include the mentioned farms; thence in a general westerly direction along the boundaries of Iris 145, Bremen 144, Oujaar 143, Koblenz 141, Tiermelkdrift, Okonguarri 94, Kabussenjama 90, Madagascar 89, Ehorongue 751, Farm 182, Rondehoek 83, so as to include these farms; thence in a general north-westerly direction along the boundaries of farms Dornputs 695, Sienna 79, Wittklipp 88, Mopane 4, Naachaams 5, Duurwater 66, Malta 7, Farm 419, Leghorn 10, Twyfel 275, Krenzhof 211, Ehobib 209, Garurib 488, Hoas 273, Amkarub 269, Vergelei 266, Katemba Autsaub 210, Geboortereg 603, Bergevallei 753, Grosheuwels

609, Bruno 614, Ombande 616, Farm 626 so as to include these farms; thence in an easterly direction to include farms Arendsnes 827; thence in a northerly direction to include Karas 237; thence in a westerly and northerly direction to the starting point.”; and

- (d) by the substitution for the paragraph “*Outjo Constituency*” of the following paragraph :

“*Outjo Constituency*

Beginning at the most north-westerly point of farm Oberland 455; thence in a general easterly direction along the southern boundary of the Etosha National Park to the most north-easterly corner of farm Renox 494 so as to include the mentioned farm; but excluding the Etosha National Park; thence in a southerly direction along farms Monty 329, Spaatzhu 761, Zkukov Oos 762, Michael 347, Elf 361, Nissen 357, Klein Huis 174 to include these farms; thence in a general westerly, southerly, south-westerly direction to include the following farms: Meyerton 175, Hopewell 240, Karachas 185, Woodholme 202, Friedental 170, Okakewa 160, Farm 162, Paresis, Bergplaas 164, Jutland 156, Tiefland 146; thence in a northerly direction along the westerly boundaries of farms Tiefland 146, Follie 147, Farm 149, Farm 134, Belina 132, Bergveld 239, De Hoop 125, Trocadero 195, Hartebeesput 229, Kaitzaas 226, Tzaas 217, Soris 213, Skuinsbank 879, Springbok 450, Eldorado 449, Farm 456 to the starting point so as to include mentioned farms in the constituency.”.

2. The item “REGION NO. 2 : OMUSATI REGION” is amended -

- (a) by the substitution for the paragraph “*Onesi Constituency*” of the following paragraph :

“*Onesi Constituency*

Beginning at Boundary Beacon 5 on the Namibia–Angola border, generally eastwards along that border for approximately 11 km to the point where the Etaka *Oshana* enters Namibia, thence generally southwards along the middle of that *oshana* to a point on the road north of Onesi where system 22/15 co-ordinate Y + 30 000 is reached, following grid direction 0° to intersect the Onesi–Tsandi road, thence along the middle of that road in a general south-easterly direction to a T-junction at approximate co-ordinates Y + 22 400 and X – 479 250 on system 22/15, thence along the fork leading in a general westerly direction to the regional boundary common to the Kunene and Omusati Regions, thence northwards along that boundary to the starting point.”;

- (b) by the substitution for the paragraph “*Uutapi Constituency*” of the following paragraph :

“*Uutapi Constituency*

Beginning at the point on the Namibia–Angola border approximately 11 km east of Boundary Beacon 5 where the Etaka *Oshana* enters Namibia,

thence along that border eastwards up to line 15°E longitude, thence southwards along that line of longitude until it intersects the middle of the Oshakati–Ruacana main road, thence in a straight line at system 22/15 grid direction 45° for approximately 2 km until a road running in a general southerly direction is intersected, thence southwards along that road for approximately 4 km until a T-junction is reached, thence eastwards for approximately 1 km and along the road south-south-east until reaching approximate co-ordinates Y – 4 500 and X – 483 500 on system 22/15 in the middle of an *oshana*, thence in a straight line at approximate grid direction 81° until the point with approximate co-ordinates Y + 22 400 and X – 479 250 on system 22/15 is reached (that point is common to the Onesi and Tsandi Constituencies), thence along the western boundaries of the Onesi Constituency in a general north-westerly direction to the starting point, so as to exclude the Onesi Constituency.”;

- (c) by the substitution for the paragraph “*Okalongo Constituency*” of the following paragraph :

“*Okalongo Constituency*”

Beginning at the point on the Namibia–Angola border approximately 6 km east of longitude 15°E where an *oshana* enters Namibia, eastwards along the border until it intersects the (i) Shaneheke *Oshana* at approximately 2 km west of Boundary Beacon 14, thence in a general southerly direction along the middle of the *oshana*, (ii) to a point with system 22/15 approximate co-ordinates Y – 48 500 and X – 486 500, thence in a straight line to the point with approximate co-ordinates Y – 29 000 and X – 482 700, being the south-eastern corner of the Anamulenge Constituency, thence in a general north-westerly direction along the middle of the *oshana* to the starting point.”;

- (d) by the substitution for the paragraph “*Elim Constituency*” of the following paragraph :

“*Elim Constituency*”

Beginning at a point where the Etaka *Oshana* intersects with the Elim–Ongandjera district road at system 22/15 approximate co-ordinate Y – 14 200, thence in a general east-north-easterly direction along the middle of that road to a point with approximate co-ordinate Y – 49 000, thence along grid direction 180° to co-ordinate X – 474 000, thence along grid direction 270° to intersect the Oshikuku–Elim district road, thence along the middle of that district road in a northerly direction for approximately 3 km, thence along grid direction 225° to intersect the Oshakati–Ruacana main road at co-ordinate Y – 54 000, thence south-eastwards along the middle of that main road to its intersection on the straight-line regional boundary common to the Omusati and Oshana Regions, thence in an approximate south-westerly direction along said boundary to a point where the middle of the Etaka *Oshana* intersects the latitude parallel of 18°02'00"S, thence generally north-westwards along the middle of that *oshana* to the starting point.”;

- (e) by the substitution for the paragraph "*Okahao Constituency*" of the following paragraph :

"Okahao Constituency

Beginning at the north-western corner point of the Etosha National Park as defined in Schedule 2 of Nature Conservation Ordinance No. 4 of 1975, northwards along the regional boundary common to the Kunene and Omusati Regions to the south-western corner of the Tsandi Constituency; thence in a general north-easterly direction along the boundary of that constituency which is a road, to its intersection with line 18°00'00"E longitude and at approximate latitude 18°00'00"S; thence northwards along that line of longitude to a point at system 22/15 co-ordinate X-45200; thence north-eastwards in a straight line to the middle of the Tsandi-Ongandjera district road at approximate co-ordinate Y-3200; thence along grid direction 270° to the middle of the Ongandjera-Ombalantu road where it intersects the Etaka *oshana*; thence south-eastwards along the middle of that *oshana* to the regional boundary common to the Omusati and Oshana Regions; thence along that boundary to the northern boundary of Etosha National Park, at a point in the middle of a road with system 22/15 approximate co-ordinates Y-5700 and X-368000, thence approximately south-westwards along middle of that road to a T-junction at approximate co-ordinate X-358500; thence along the fork generally south-eastwards, southwards and south-westwards to a T-junction at approximate co-ordinate X-331400; thence south-eastwards along the middle at the Otjovansandu-Okaukuejo road to a T-junction at approximate co-ordinate Y-63500; thence along the middle of the road approximately westwards to a T-junction at approximate co-ordinate Y-33500; thence generally southward with the fork to the north-eastern corner beacon of the Farm Safari 663, thence westwards, southwards, eastwards, southwards and westwards along the southern boundary of the Etosha National Park; thence approximately northwards along the same boundary (middle of Kamanjab-Ruacana main road) to a point where it intersects with the straight line boundary at the Etosha National Park; thence north-eastwards, north-westwards and northwards along that boundary to the starting point."; and

- (f) by the addition of the following paragraphs :

"Etayi Constituency

Beginning at a point on the Namibia–Angola border at approximately 2 km west of Boundary Beacon 14 where the Shaneheke *Oshana* enters Namibia, thence eastwards along the border until it intersects the Shakambebe *Oshana*, thence in a general southerly direction along the middle of the *oshana*, along the regional boundary to the corner point common to the Omusati, Ohangwena and Oshana Regions which is localised by system 22/15 approximate co-ordinates Y – 69 500 and X – 479 000, thence in an approximate south-westerly direction along the straight-line regional boundary common to the Omusati and Oshana Regions until it intersects the middle of the Oshakati–Ruacana main road, thence generally north-westwards along the middle of that road to

the point where the Oshikuku / Okalongo road turns of northwards (excluding Oshikuku from that Constituency); thence northwards along the middle of the last mentioned road to its intersection with the straight line boundary of the Okalongo Constituency at approximate co-ordinate Y-48 500, thence along that boundary eastwards to its intersection in the middle of the Shaneheke Oshana, thence approximately northwards along the middle of that *oshana* to the starting point.”; and

“Ruacana Constituency

Beginning at Boundary Beacon 1 on the Namibia/Angola border; thence eastwards along that border to boundary beacon 5, where the Onesi Constituency starts; thence southwards along the western constituency boundaries at the Onesi Tsandi, and Okahao Constituencies to the north-western corner beacon of the Etosha National Park as defined in Schedule 2 of the Nature Conservation Ordinance, 1975 (Ordinance No. 4 of 1975); thence southwards, south-eastwards and south-westwards along the Etosha National Park boundary to a point where it intersects the Ruacana-Kamanjab main road; thence along the middle of that road to the Ombombo border check point with system 22/15 approximate north-westwards along a road for approximately 33 kilometres to the Ombarandu border check point at approximate co-ordinates Y+90600 and X-461700; thence along the middle of a road running north-eastwards, northwards, north-westwards, northwards, north-eastwards and northwards to the Ruacana Rest Camp at approximate co-ordinates Y+83000 and X-508000; thence in grid direction 0°00'00" the middle of the Kunene River (Namibian/Angola border); thence northwards along the middle of that river to a point of beginning.”.

3. The item No. 3 : OSHANA REGION is amended -

- (a) by the substitution for the paragraph *“Oshakati Constituency”* of the following paragraphs :

“Oshakati East Constituency

This constituency comprises the former Oshakati Constituency, including the Townships of Oshakati Extension 2 and Oshakati Extension 3 in the Oshakati East Constituency, but excluding that part of the Oshakati Constituency now falling within the limits of the Oshakati West Constituency.”; and

“Oshakati West Constituency

This constituency consists of that part of the former Oshakati Constituency, lying west of a line starting at beacon C on diagram A65/ 91 of the farm Oshakati Town and Townlands 880, thence south-westwards along a straight line to the easternmost corner beacon of the boundary of the Township of Oshakati Extension 5, thence westwards and southwards along the boundary of that township until meeting the boundary of the Township of Oshakati Extension 4, thence south-eastwards south-westwards south-eastwards along the boundary of the

last-mentioned township until meeting the boundary of the Township of Oshakati Extension 1, thence south-eastwards along that township boundary until meeting the boundary of the Township of Oshakati Extension 2, thence approximately south-westwards along the common boundary of Oshakati Extension 1 and Oshakati Extension 2 to a point common to these two last-mentioned townships and Portion 10 of the farm Oshakati Town and Townlands 880, thence along the common boundary between the last-mentioned farm portion and Oshakati Extension 2 to a point common to that portion, Oshakati Extension 2 and Oshakati Extension 3, thence westwards and south-westwards along the common boundary between that portion and Oshakati Extension 3 to the westernmost corner beacon of the last-mentioned township, thence approximately south-westwards in a straight line to beacon F on diagram A65/91 of the farm Oshakati Town and Townlands 880, thence southwards in a straight line until grid line X – 450 000 on system 22/15 is intersected, to include the Townships of Oshakati, Oshakati Extension 1, Oshakati Extension 4 and Oshakati Extension 5 in the Oshakati West Constituency.”;

- (b) by the substitution for the paragraph “*Ondangwa Constituency*” of the following paragraph :

“*Ondangwa Constituency*

Beginning at the point where the centre line of the Oshakati–Ondangwa main road crosses the western boundary of the farm Ondangwa Town and Townlands 882 northwards, eastwards, southwards and westwards along the boundaries of that farm to the beacon marked D on diagram A64/91 of that farm so as to include the farm in the constituency, thence from that beacon approximately 1,5 km along line D-E until grid line X–450 000 on system 22/15 is intersected, thence westwards along that grid line until it intersects the middle of the *oshana* draining southwards into the so-called Lake Oponono, thence in a general northerly direction along the middle of that *oshana* to the centre line of the Oshakati–Ondangwa main road, thence along the centre line of that main road in a general easterly and south-easterly direction to the starting point.”;

- (c) by the substitution for the paragraph “*Uukwiyu Constituency*” of the following paragraph :

“*Uukwiyu Constituency*

Beginning at the south-western corner of the Ondangwa Constituency, i.e. at the point – where grid line X – 450 000 on system 22/15 intersects the middle of the *oshana* which drains generally southwards to the so-called Lake Oponono, thence eastwards – along the southern boundary of the Ondangwa Constituency to the south-eastern corner of the Ondangwa Constituency; thence southwards along the regional boundary until the road junction at approximate latitude 18°01'S is reached, thence along the middle of the road in a general south-westerly direction – for approximately 5,5 km, thence westwards for approximately 16 km along a track, thence northwards for approximately 2 km along the same track

until it forms a T-junction with another track, thence generally westwards along the last-mentioned track until its intersection with the middle of the *oshana* which drains generally southwards to the so-called Lake Oponono; thence northwards along the middle of the *oshana* to the starting point.”;

- (d) by the substitution for the paragraph “*Okatyali Constituency*” of the following paragraph :

“*Okatyali Constituency*

Beginning at the T-junction of the roads forming a corner point of the Uukwiyu Constituency near latitude 18°01'S and longitude 16°E along the middle of the road for approximately 2 km until joining the north-south road from Olukonda, thence along the middle of that road in a general southerly direction until the co-ordinate of X – 400 000 on system 22/15 is reached, thence westwards at grid direction 90° to the middle of the Ekuma *Oshana*, thence along the middle of that *oshana* in a general northerly direction to the southernmost corner point of the Uukwiyu Constituency, thence along the middle of the road in a general north-easterly direction to the starting point.”; and

- (e) by the substitution for the paragraph “*Uuvudhiya Constituency*” of the following paragraph :

“*Uuvudhiya Constituency*

Beginning at the southernmost corner point common to the Oshana and Omusati Regions; thence in general northerly, north-westerly and north-easterly directions along the boundaries common to that Regions to the westernmost corner point of the Okatana Constituency; thence in a clockwise direction from that point, the Constituency is bounded in succession by boundaries which are common with the Okatana Constituency and the Ompundja Constituency and the Uukwiyu Constituency and the Okatjali Constituency; thence at the middle of the Ekuma *Oshana* southwards to a point where it drains into the Etosha Pan with system 22/17 at approximate co-ordinate Y+102500; thence south-westwards, southwards and south-eastward along the western edge of the Etosha Pan to its intersection with a road with system 22/15 at approximate co-ordinate Y-102200; thence southwards along the middle of that road, until its intersection with the Halali-Okaukuejo main road; thence westwards along the middle of the last-mentioned road, including Okaukuejo into that Constituency; thence southwards along the middle of the Okaukuejo-Outjo main road until its intersection with the southern boundary of the Etosha National Park; thence westwards and northwards along the southern boundary of that Park up to the north-eastern corner beacon at the Farm Safari 663; thence northwards along a road to a T-junction with approximate co-ordinate Y-33500; thence eastwards along the fork to a T-junction with the Okaukuejo-Otjivasando main road with approximate co-ordinate; thence north-westwards along the fork to a T-junction with co-ordinate X-331400; thence north-eastwards, northwards and north-westwards to a T-junction with approximate co-ordinate X-

358500; thence approximate northwards along the fork to a point on the northern boundary of the Etosha National Park at approximate co-ordinates Y-57000 and X-368000; thence eastwards to the starting point.'.

4. The item "OHANGWENA REGION" is amended -

- (a) by the substitution for the paragraph "*Eenhana Constituency*" of the following paragraph :

"Eenhana Constituency

This constituency comprises the former Eenhana Constituency, but excluding that part of the constituency now falling within the limits of the Omundaungilo Constituency."; and

- (b) by the substitution for the paragraph "*Omundaungilo Constituency*" of the following paragraph :

"Omundaungilo Constituency

Beginning at the point where a road joins the Namibia–Angola border at system 22/17 approximate co-ordinate Y + 73 000, eastwards to a point where a road from the south joins that border at approximate co-ordinate Y + 13 300, thence along middle of that road southwards to its intersection with the Okongo–Eenhana district road, thence along the middle of that district road in an approximate west-south-westerly direction to the starting point at the fork in the district road north of Elundu at approximate co-ordinate Y+47 000, thence along the fork leading in a general south-easterly direction for approximately 1 km to a T-junction, thence along the fork leading in a general southerly direction to a T-junction at approximate co-ordinate Y + 43 500, thence along the fork leading in a general westerly and north-westerly direction to a T-junction at approximate co-ordinate Y + 60 200, thence northwards along the fork, crossing the Okongo–Eenhana district road and continuing in a west-north-westerly direction to a point at co-ordinates Y + 69 500 and X – 502 000, thence in grid direction 90° to intersect the road running north from Eenhana, thence northwards along the middle of the last-mentioned road to the starting point."

5. The item "REGION NO. 5 : OSHIKOTO REGION" is amended -

- (a) by the substitution for the paragraph "*Omuthiyagwiipundi Constituency*" of the following paragraph :

"Omuthiyagwiipundi Constituency

Beginning at a point in the middle of the Ekuma Oshana where it intersects the Etosha National Park as defined in Schedule 2 of the Nature Conservation Ordinance, 1975 (Ordinance No. 4 of 1975) at system 22/15 approximate co-ordinate Y-100000; thence eastwards along that Etosha until its intersection with the Nipele *Omuramba* upstream along the middle of the omuramba in a general northerly direction; thence

approximately 2 km after crossing the Ondangwa-Tsumeb trunk road proceeding along the middle of a tributary entering the Nipele Omuramba from the north-east; thence at system 22/17 approximate co-ordinates Y+50000 and X-426000 that tributary is crossed by a road coming southwards from Okankolo, proceeding in a general south-easterly direction along the middle of the road to its intersection with the centre line of the Ondangwa-Tsumeb trunk road; thence along the centre line of that trunk road eastwards for approximately 22,5 km to the boundary of the Etosha National Park; thence south-eastwards, southwards, westwards, southwards, south-westwards and westwards, along the Etosha National Park boundary until its intersection with the Okaukuejo-Outjo main road; thence northwards along that main road, excluding Okaukuejo from that Constituency; thence eastwards along the middle of the Okaukuejo-Halali main road until its intersection with a road to the north at approximate co-ordinate Y-100400; thence northwards along the middle of that road to its intersection with the Etosha Pan at approximate co-ordinate Y-102200; thence north-westwards, northwards and north-eastwards to a point with system 22/17 approximate co-ordinate Y+100000 where the Ekuma Oshana drains into the Etosha Pan; thence northwards upstream in the middle of that Oshana to the starting point.'; and

- (b) by the substitution for the paragraph "*Engodi Constituency*" of the following paragraph :

"Engodi Constituency

Beginning at the easternmost corner of the Onyaanya Constituency, i.e. at the intersection of the stream and road at system 22/17 approximate co-ordinates Y + 50 000 and X – 426 000, along the southern boundaries of the Okankolo Constituency in general north-easterly, easterly, northerly and easterly directions to line of longitude 18°E, thence southwards along that meridian to latitude 18°28'30"S, thence in a straight line in a general westerly direction to the beginning of the Omuthiya *Omuramba*, thence along the middle of that *omuramba* to a point where it intersects the middle of the Ondangwa-Tsumeb trunk road, thence westwards along the middle of that trunk road until its intersection with the road from Okankolo, thence north-westwards along the middle of that road to the starting point."

6. The item "REGION NO. 6 : OKAVANGO REGION" is amended -

- (a) by the substitution for the heading "REGION NO. 6 : OKAVANGO REGION" of the heading "REGION NO. 6 : KAVANGO REGION";
- (b) by the substitution for the paragraph "*Mpungu Constituency*" of the following paragraph :

"Mpungu Constituency

Beginning at the point where the Namibia-Angola border intersects line 18°00'00"E longitude, thence eastwards along that border until the middle

of the Kavango River is reached, thence along the middle of that river in a general south-easterly direction to a point at system 22/19 approximate co-ordinate Y + 50 000, thence in approximate grid direction 15° in a straight line for about 11,5 km to a point where line 18°30'00"E longitude intersects with line 18°00'00"S latitude, thence approximately southwards in a straight line to the north-western corner beacon of the Farm 1047, thence westwards along the northern boundaries of the Grootfontein District as defined in schedule Q to Government Notice R.1148 of 1972 and part of the district of Tsumeb as defined in Government Notice 99 of 1977 to a point where line 18°00'00"E longitude intersects, thence northwards along that line of longitude to the starting point.

- (c) by the substitution for the paragraph "*Kahenge Constituency*" of the following paragraph :

"Kahenge Constituency

Beginning at a point in the middle of the Kavango River at system 22/19 approximate co-ordinate Y-63 500, thence downstream along the middle of that river to co-ordinate Y-29 000, thence approximately southwards along a straight line to the north-eastern corner beacon of the farm Wildhagen 1019, thence westwards along the northern boundary of the Grootfontein District as defined in Schedule Q of Government Notice R.1148 of 1972 up to the north-western corner beacon of the Farm 1047, thence approximately northwards in a straight line to a point where line 18°30'00"E longitude intersects line 18°00'00"S latitude, thence in approximate grid direction 198° in a straight line approximately north-eastwards for about 14,5 km to the starting point.";

- (d) by the substitution for the paragraph "*Kapako Constituency*" of the following paragraph :

"Kapako Constituency

Beginning at the point in the middle of the Kavango River on the Namibia-Angola border at system 22/19 approximate co-ordinate Y - 29 000, along the middle of that river to a point at approximate co-ordinate Y - 75 000, thence southwards to the beacon A on diagram A339/91 of the farm Rundu Townlands No. 1329, thence along the western boundary of the last-mentioned farm southwards to where line 18°00'00"S latitude intersects with line of 19°30'00"E longitude, thence southwards along that line of longitude to a point where it intersects the Rundu-Grootfontein road, thence approximately south-eastwards in a straight line to a point in the middle of the Omatako *Omuramba* at approximate co-ordinate X - 376 500 in the general prolongation of a track coming from the west, thence along the middle of the *omuramba* in a general southerly and south-westerly direction until it reaches the regional boundary common to the Kavango and Otjozondjupa Regions, thence along that regional boundary westwards and northwards to the north-eastern corner beacon of the farm Wildhagen 1019, thence approximately northwards in a straight line to the starting point.";

- (e) by the substitution for the paragraph "*Rundu Constituency*" of the following paragraphs :

"Rundu Urban Constituency

This constituency comprises the Townships of Rundu, Rundu Extension 1, Rundu Extension 2, Rundu Extension 3, Rundu Extension 5, Rundu Extension 6 and Rundu Extension 7."; and

Rundu Rural Constituency

Beginning at Beacon A on diagram A339/91 of the farm Rundu Townlands No. 1329, thence northwards to a point in the middle of the Kavango River at system 22/19 approximate co-ordinate Y – 75 000, downstream in a general easterly direction along the middle of that river to a point where line 20°00'00"E longitude intersects, thence southwards along the middle of that line of longitude until its intersection with the Omatako *Omuramba*, thence generally south-westwards along the middle of that river to approximate co-ordinate X – 37 65 00, thence approximately north-westwards in a straight line to a point where line 19°30'00"E longitude intersects with the Rundu–Grootfontein road, thence northwards along that line of longitude to a point where it intersects with line 18°00'00"S latitude, thence approximately north-eastwards in a straight line to Beacon D of the farm Rundu Townlands No. 1329, thence along the western boundary of the last-mentioned farm northwards to the starting point, and includes the Township Rundu Extension 4, but excludes the Rundu Urban Constituency.";

- (f) by the substitution for the paragraph "*Mashare Constituency*" of the following paragraph:

"Mashare Constituency

Beginning at a point where line 20°00'00"E longitude intersects the middle of the Kavango River, downstream in a general easterly direction along the middle of that river to a point where line 20°25'00"E longitude intersects, thence southwards along that line of longitude and its prolongation to the regional boundary common to the Kavango and Otjozondjupa Regions, thence westward along that regional boundary to its intersection with the Omatako *Omuramba*, thence generally north-eastwards along the middle of the *omuramba* to a point where it intersects line 20°00'00"E longitude, thence northwards along that line of longitude to the starting point.

- (g) by the substitution for the paragraph "*Ndiyona Constituency*" of the following paragraph :

"Ndiyona Constituency

Beginning at a point where line 20°25'00"E longitude intersects the middle of the Kavango River, downstream in a general easterly direction along the middle of that river until its intersection with line 21°00'00"E

longitude, thence along that line of longitude southwards to the 'corner' of the Namibia-Botswana border, continuing to line 18°15'00"S latitude until the east-west regional boundary common to the Kavango and Otjozondjupa Regions is reached, thence along that regional boundary westwards to a point where it intersects line 20°25'00"E longitude, thence northwards along that line of longitude to the starting point."; and

- (h) by the substitution for the paragraph "*Mukwe Constituency*" of the following paragraph :

"Mukwe Constituency

Beginning at the point where line 21°00'00"E longitude intersects the middle of the Kavango River, downstream along the middle of the river eastwards to Dikuyu Island, thence approximately eastwards along the Namibia-Angola straight-line border to a point where line 22°30'00"E longitude crosses that border, thence southwards along that line of longitude until the Namibia-Botswana border is met, thence along that border in a general westerly direction to 21°00'00"E longitude, thence northwards along that line of longitude to the starting point.

7. The item "REGION NO. 7 : CAPRIVI REGION" is amended -

- (a) by the substitution for the paragraph "*Kongola Constituency*" of the following paragraph :

Beginning at a point where line 22°30'00"E longitude crosses the Namibia-Angola border, thence approximately eastwards along the border to a point where the Kwando River enters Namibia, thence approximately eastwards along the Namibia-Zambia straight-line border to a point meeting system 22/25 co-ordinate Y + 87 000, thence along grid direction 341°30'00" to meet the middle of the Katima Mulilo to Kongola road (the 'Golden Highway'), thence along the middle of that road in a general westerly direction until it crosses the middle of the Kwando River at Kongola Bridge, thence along the middle of that river in a general southerly direction until the Namibia-Botswana border is met, thence along that border in a general westerly direction to a point where line 22°30'00"E longitude crosses that border, thence northwards along that line of longitude to the starting point."; and

- (b) by the substitution for the paragraph "*Katima Mulilo Constituency*" of the following paragraphs :

"Katima Mulilo Urban Constituency

This constituency comprises the farm Katima Mulilo Townlands No. 1328 as represented by diagram A332/91, and excludes the Township Katima Mulilo Extension 7 as represented by General Plan B114, as well as the area south of that township up to the boundary of the farm Katima Mulilo Townlands No. 1328, beginning at a point defined by system 22/25 at co-ordinates Y + 77 365,52 and X - 495 525,32 along the southern boundary of the Township Katima Mulilo Extension 7 to a

point at co-ordinate Y + 75 803,20.”; and

“Katima Mulilo Rural Constituency

This constituency comprises the former Katima Mulilo Constituency, but excluding the area now falling within the limits of the Katima Mulilo Urban Constituency.”; and

- (c) by the deletion of the paragraph *“Mukwe Constituency”*

8. The item “REGION NO. 8 : ERONGO REGION” is amended -

- (a) by the substitution for the paragraph *“Brandberg Constituency”* of the following paragraph :

“Dâures Constituency

This constituency comprises the former Brandberg Constituency, but excluding the following part of that Constituency now falling within the limits of the new Arandis Constituency :

The area south of the following boundary description : starting at a point where the road from the Martin Luther 1896 Monument intersects the eastern boundary of the Walvis Bay Constituency with system 22/15 approximate co-ordinates Y + 34 200 and X + 81 800, thence approximately east-wards along the middle of that road to a point where it intersects line 15°00'00"E longitude, thence southwards for approximately 23 km along that line of longitude until it intersects the Gamsberg Pass main road from Walvis Bay to Windhoek, thence approximately eastwards along the middle of that main road until it intersects the regional boundary common to the Erongo and Khomas Regions which was formerly part of the Swakopmund Constituency.”;

- (b) by the substitution for the paragraph *“Arandis Constituency”* of the following paragraph :

“Arandis Constituency

This constituency comprises the following:

- (i) The former Swakopmund Constituency, excluding that part of that Constituency now falling within the limits of the Walvis Bay Rural Constituency and the new Swakopmund Constituency;
- (ii) the former Arandis Constituency, excluding that part of that Constituency now falling within the limits of the Swakopmund Constituency; and
- (iii) the area south of the straight line starting at a point on the boundary between the former Swakopmund and Brandberg Constituencies, with approximate geographical co-ordinates 22°00'00"S latitude and 14°35'00"E longitude, thence south-eastwards in a straight line

to the north-western corner beacon of the farm Trekkopje/20, but excluding that farm.”;

- (c) by the substitution for the paragraph “*Swakopmund Constituency*” of the following paragraph :

“Swakopmund Constituency

This constituency comprises the Municipal Area of Swakopmund as defined in Government Notice No. 1 of 1989.”; and

- (d) by the substitution for the paragraph “*Walvis Bay Constituency*” of the following paragraphs :

“Walvis Bay Urban Constituency

This constituency comprises the following proposed wards: Ward 1, Ward 2, Ward 3, Ward 4, Ward 7, Ward 9 and Ward 10, which fell within the former Walvis Bay Constituency.”; and

“Walvis Bay Rural Constituency

This constituency comprises the following:

- (i) Ward 5, Ward 6 and Ward 8, which fell within the former Walvis Bay Constituency;
- (ii) the former Walvis Bay Constituency, excluding that part of that constituency now falling within the limits of the Walvis Bay Urban Constituency; and
- (iii) The area south of the following boundary description: starting at a point where the road from the Martin Luther 1896 Monument intersects the eastern boundary of the former Walvis Bay Constituency with system 22/15 approximate co-ordinates Y + 34 200 and X + 81 800, thence approximately east-wards along the middle of that road to a point where it intersects line 15°00'00"E longitude, thence southwards for approximately 23 km along that line of longitude until it intersects the Gamsberg Pass main road from Walvis Bay to Windhoek, thence approximately eastwards along the middle of that main road until it intersects the regional boundary common to the Erongo and Khomas Regions which was part of the former Swakopmund Constituency.

9. The item “REGION NO. 9 : OTJOZONDJUPA REGION” is amended -

- (a) by the substitution for the paragraph “*Grootfontein Constituency*” of the following paragraph :

“Grootfontein Constituency

This constituency comprises the former Grootfontein Constituency, excluding the area now falling within the limits of the Tsumkwe

Constituency.”; and

- (b) by the addition of the following paragraph :

“Tsumkwe Constituency

Beginning at a point where the northern boundary of the communal area Bushmanland’ meets the eastern boundary of the Grootfontein District as defined in schedule Q of Government Notice R.1148 of 1972, at approximately the middle of the eastern boundary of the Farm Talitha 1006, thence eastwards along the straight-line northern boundary of the Bushmanland communal area to the Namibia–Botswana border, thence southwards along that border to its intersection with the middle of the Otjozondjou *Omuramba*, thence along the middle of the *omuramba* or its northern arm where applicable until its intersection with line 19°00’00”E longitude, thence in a northerly direction in a straight line to the southernmost corner beacon of the farm Sandveld Game Ranch 1265, thence along the boundaries of the Grootfontein District in a general north-westerly direction to the south-western corner beacon of the farms Blystroom 947, Eden Nature Reserve 1264, Terazzo 951, Onjama 952, Simondeum 991 and Farm 992, thence from the south-western corner beacon of the last-mentioned farm, northwards along the relevant borders of Farm 992, Alpha 997, Deodate 998, Fair Constantia 1003, Kalaharikroon 1004, Rosevlakte 1009, Saamgewaagd 1010, Farm 1015, Farm 1016 and Farm 1021 so as to include them in the constituency, thence from the north-western corner beacon of the last-mentioned farm, eastwards and southwards along the regional boundary common to the Kavango and Otjozondjupa Regions, along the relevant borders of Farm 1021, Farm 1020, Wildhagen 1019, Wildgrund, Farm 1013, Verskyn 1012, Hero 1007 and Talitha 1006 so as to include them in the constituency, to the starting point.”.

10. The item “REGION NO. 10 : OMAHEKE REGION” is amended -

- (a) by the substitution for the the heading of the paragraph “*Otjozondjou Constituency*” of the heading “*Otjimbinde Constituency*”;
- (b) by the substitution for the paragraph “*Steinhausen Constituency*” of the following paragraph :

“Steinhausen Constituency

This constituency comprises the following:

- (i) The former Steinhausen Constituency; and
- (ii) that part of the former Gobabis Constituency lying north of the following line:

Beginning at a point in the middle of the Windhoek–Gobabis main road where it intersects the regional boundary between the Omaheke and Khomas Regions, thence eastwards along the middle

of that main road until its intersects with the western boundary of the area of the village of Witvlei as defined in Proclamation 25 of 1990 (Peri-Urban Area of Witvlei), thence southwards, eastwards and northwards along the boundary of that village until its intersection with the Windhoek–Gobabis main road to include that village in the Steinhausen Constituency, thence eastwards along the middle of that main road until its intersection with the western boundary of the farm Kranz 169, thence northwards and eastwards along the boundaries of the farms Kranz 169 and Annasru 17 to exclude them from the Steinhausen Constituency, to a point where it intersects the constituency boundary common to the Gobabis and Kalahari Constituencies, that also being the point of the north-eastern corner beacon of the farm Annasruh 175.

- (c) by the substitution for the paragraph “*Gobabis Constituency*” of the following paragraph :

“*Gobabis Constituency*”

That Constituency comprises the former Gobabis Constituency, excluding that part of the constituency now falling within the limits of the Kalahari Constituency, namely Nossobville Township, as represented by General Plan, and excluding that part of the Gobabis Constituency now falling within the Steinhausen Constituency lying north of the followig line:

Beginning at a point in the middle of the Windhoek–Gobabis main road where it intersects the regional boundary between the Omaheke and Khomas Regions, thence eastwards along the middle of that main road until its intersects with the western boundary of the area of the village of Witvlei as defined in Proclamation 25 of 1990 (Peri-Urban Area of Witvlei), thence southwards, eastwards and northwards along the boundary of that village until its intersection with the Windhoek–Gobabis main road to include that village in the Steinhausen Constituency, thence eastwards along the middle of that main road until its intersection with the western boundary of the farm Kranz 169, thence northwards and eastwards along the boundaries of the farms Kranz 169 and Annasru 17 to exclude them from the Steinhausen Constituency, to a point where it intersects the constituency boundary common to the Gobabis and Kalahari Constituencies, that also being the point of the north-eastern corner beacon of the farm Annasruh 175.” ; and

- (d) by the substitution for the paragraph “*Buitepos Constituency*” of the following paragraph :

“*Kalahari Constituency*”

“This constituency comprises the former Buitepos Constituency, including the Township of Nossobville as represented by General Plan.”.

11. The item “REGION NO. 11 : KHOMAS REGION” is amended -

- (a) by the substitution for the paragraph “*Wanaheda Constituency*” of the

following paragraph :

“Wanaheda Constituency

This Constituency comprises the Townships of Goreangab, Wanaheda, Wanaheda Extension 2, Wanaheda Extension 3, Wanaheda Extension 4, Wanaheda Extension 5, Wanaheda Extension 6, Wanaheda Extension 7 and Wanaheda Extension 8, plus the remainder of the farm Gammams 36 and subdivisions.”; and

- (b) by the substitution for the paragraph *“Hakahana Constituency”* of the following paragraph :

“Hakahana Constituency

This constituency comprises the Townships of Hakahana, Okuryangava, Okuryangava Extension 1, Okuryangava Extension 2, Okuryangava Extension 3, Okuryangava Extension 4, Okuryangava Extension 5 and Lafrenz, as well as the remainder of the farm Nubuamis 37 and subdivisions, the remainder of the farm Ongava 452 and subdivisions and the remainder of the Farm Ujams 288 and sub-divisions.”.

12. The item “REGION NO. 12 : HARDAP REGION” is amended -

- (a) by the substitution for the paragraph *“Rehoboth West Urban Constituency”* of the following paragraph :

“Rehoboth West Urban Constituency

This constituency comprises the Townships of Rehoboth Block A, Rehoboth Block A Extension 1, Rehoboth Block A Extension 2, Rehoboth Block D, Rehoboth Block D Extension 1, Rehoboth Block F, Rehoboth Block F Extension 1, Rehoboth Block F Extension 2 and Rehoboth Block G, plus that part of the farm Rehoboth Dorpsgrond Townlands 302 lying west of Trunk Road 1 (Windhoek–Rehoboth–Mariental), and properties lying within the boundaries of that farm.”;

- (b) by the substitution for the paragraph *“Rehoboth East Urban Constituency”* of the following paragraph :

“Rehoboth East Urban Constituency

This constituency comprises the Townships of Rehoboth, Rehoboth Block B, Rehoboth Block C, Rehoboth Block E, Rehoboth Block E Extension 1, Rehoboth Block E Extension 2, Rehoboth Block E Extension 3 and Rehoboth Block H, plus that part of the farm Rehoboth Dorpsgrond Townlands 302 lying east of Trunk Road 1 (Windhoek–Rehoboth–Mariental), as well as properties lying within the boundaries of that farm.”;

- (c) by the substitution for the paragraph *“Rehoboth Rural Constituency”* of the following paragraph :

This constituency comprises the former Rehoboth Rural Constituency, plus that area of the village of Kalkrand defined in Proclamation 29 of 1980 (Peri-Urban Area: Kalkrand).”;

- (d) by the substitution for the paragraph “*Mariental Rural Constituency*” of the following paragraph :

“*Mariental Rural Constituency*

This constituency comprises the former Mariental Rural Constituency, less that area of the village of Kalkrand as defined in Proclamation 29 of 1980 (Peri-Urban Area: Kalkrand) which now forms part of the Rehoboth Rural Constituency.”; and

- (e) by the substitution for the paragraph “*Mariental Urban Constituency*” of the following paragraph :

“*Mariental Urban Constituency*

This constituency comprises the former Mariental Urban Constituency, excluding that area of the Village of Kalkrand, as defined in Proclamation 29 of 1980 (Peri-Urban Area: Kalkrand) which now forms part of Rehoboth Rural Constituency”.
