TO AMEND ITS FOUR YEAR COMMUNITY SOUND BROADCASTING AND
SIGNAL DISTRIBUTION LICENCE FOR RADIO SHIMLA (RSFM)**

Independent Communications Authority of South Africa hereby gives notice in accordance with the provisions of section 52 (2) of the IBA Act, as amended, that it has received an application in accordance with the provisions of section 52(1)(c) of the Act, for an amendment of the broadcasting licence of the University of the Free State, broadcasting as Radio Shimla (RSFM).

The applicant seeks the Authority's approval for the following:

1. To change the name of the station from Radio Shimla (RSFM) to 97FM;
2. To change its broadcasting hours from 17 hours daily to 24 hours;
3. To change its transmission site from the Sasol Library Building at the University main campus to a Sentech transmitter site at Naval Hill, Bloemfontein with Sentech as its signal distributor; and
4. To increase its ERP from 20 watt to 100 watt.
