CALL FOR NOMINATIONS: MEMBERS OF THE SPECIAL ECONOMIC ZONES ADVISORY BOARD (SEZ)

The Special Economic Zones Act, 2014 (Act No.16 of 2014), established the SEZ Advisory Board to provide advice to the Minister on the designation, promotion, development, operation and management of SEZs; to provide for the establishment, appointment of Members and functioning of the SEZ Advisory Board; to provide for the establishment of the SEZ fund; to regulate the application, issuing, suspension, withdrawal and transfer of SEZ operator permits; to provide for functions of the SEZ operator; to provide for transitional arrangements and to provide for matters connected therewith.

Requirements: Candidates should have leadership and governance experience, relevant qualifications and knowledge, experience and expertise in the fields relevant to SEZs.

The composition of the Board is set out in the SEZ Act and includes:

- three persons, each representing organised business, labour and civil society appointed based on their knowledge and experience and expertise relevant to, and involvement in SEZs; and
- five independent persons appointed based on their knowledge, experience and expertise relevant to SEZs.

Disqualification of membership: A person may not be a member of the Advisory Board if that person: (a) is an unrehabilitated insolvent; (b) has been declared by a High Court with Jurisdiction to be mentally ill; (c) has been convicted of an offence in the Republic or elsewhere, other than an offence committed prior to 27 April 1994 associated with a political objective, and sentenced to imprisonment without the option of a fine or, in the case of fraud or any other offence involving dishonesty, to a fine or imprisonment or both a fine and imprisonment; (d) has at any time been removed from an office of trust on account of breach of fiduciary duties; or (e) is otherwise disqualified in terms of section 69 of the Companies Act, 2008 (Act No.71 of 2008).

Term of office: Members will be appointed for a period of five (5) years.

Remuneration: Rates as determined and published by the National Treasury.

CALL FOR NOMINATIONS: TRUSTEES OF THE BOARD OF THE NATIONAL EMPOWERMENT FUND (NEF)

The NEF was established by the National Empowerment Fund Act No 105 of 1998 (the Act). The NEF is a driver and thought-leader in promoting and facilitating black economic participation by providing financial and non-financial support to black-owned and managed businesses, and by promoting a culture of savings and investment among black people.

Requirements: Candidates should have leadership and governance experience, must be persons who are committed to (a) fairness, transparency, and accountability on the part of those entrusted with the public office; and (b) the objects and principles of the Act.

When viewed collectively, the Trustees must (a) predominantly represent a broad cross-section of the historically disadvantaged persons of the Republic; (b) possess expertise and experience in the fields of, amongst others; development finance; law, economics, business practice, development practice, capital markets and finance; (c) be reasonably reflective of the gender composition of historically disadvantaged persons; and (d) be fairly representative of various provinces of the Republic.

In terms of the Act, a person may not be appointed as a Trustee if such person (a) is not a citizen of the Republic; (b) is not permanently resident in the Republic; (c) is an unrehabilitated insolvent; (d) is of unsound mind, or is subject to an order of a competent court declaring such person to be mentally ill or mentally disordered; (e) has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery and uttering, perjury, an offence in terms of the Corruption Act, 1992 (Act No. 94 of 1992), or any other offence involving dishonesty; or (f) has at any time been removed from an office of trust on account of misconduct.

Term of office: Trustees shall be appointed for a term of up to three (3) years.

Remuneration of Trustees: Rates as determined and published by the National Treasury.

CALL FOR NOMINATIONS: THREE FULL-TIME MEMBERS OF THE COMPETITION TRIBUNAL

The Competition Tribunal was established by the Competition Act, (Act No 89 of 1998) (the Act) as amended, upon a matter being referred to it in terms of this Act; grant an exemption from a relevant provision of this Act; authorise a merger; with or without conditions; or prohibit a merger; adjudicate in relation to any conduct prohibited in terms of Chapter 2 or 3, by determining whether prohibited conduct has occurred and if so impose a remedy provided for in Chapter 6; or grant an order for costs in terms of section.

Requirements: Members must represent a broad cross-section of the population of the Republic; and comprise sufficient persons with legal training and experience. Each member of the Competition Tribunal must be a citizen of South Africa, who is ordinarily resident in South Africa; have suitable qualifications and experience in economics, law, commerce, industry or public affairs; and be committed to the purposes and principles of Section 2 the Competition Act, (Act No 89 of 1998) (the Act) as amended.

In term of section 28(3) of the Act, a person may not be a member of the Competition Tribunal if that person is an office-bearer of any party, movement, organisation or body of a partisan political nature; is an unrehabilitated insolvent; is subject to an order of a competent court holding that person to be mentally unfit or disordered; or has been convicted of an offence committed after the Constitution of the Republic of South Africa, 1993 (Act No. 200 of 1993), took effect, and sentenced to imprisonment without the option of a fine

Term of office: The Tribunal Members will be appointed for a period of five (5) years.
