**NOTIFICATION TO INTRODUCE THE SOUTH AFRICAN NATIONAL
WATER RESOURCE INFRASTRUCTURE AGENCY SOC LIMITED
AMENDMENT BILL, 2025 INTO PARLIAMENT AND PUBLICATION OF
EXPLANATORY SUMMARY OF THE BILL**

Minister, Miss Pemmy. C. Majodina, intends to introduce the South African National Water Resource Infrastructure Agency SOC Limited Amendment Bill, 2025, into Parliament. The following Explanatory Summary of the Bill is hereby published in accordance with Rules 271 and 276 (1)(b) and (c) of the Rules of the National Assembly.

The South African National Water Resources Infrastructure Agency SOC Limited Amendment Bill, 2025 (the "Bill") amends the South African National Water Resources Infrastructure Agency SOC Limited Act, Act 34 of 2024 (the "Act"). The Bill seeks to:

- (a) To provide for the listing of the Agency in Schedule 2 to the Public Finance Management Act; and

- (b) to provide for the delisting of the TCTA from Schedule 2 to the Public Finance Management Act.
