Public comments are to be sent in writing. Such comments should specify which of the three documents the comments relates to including specific details on section or clause for which the comments relates to. Public comments should include the name of the person/stakeholder/ organisation submitting comments as well as contact details such as postal address, telephone number and email address.
