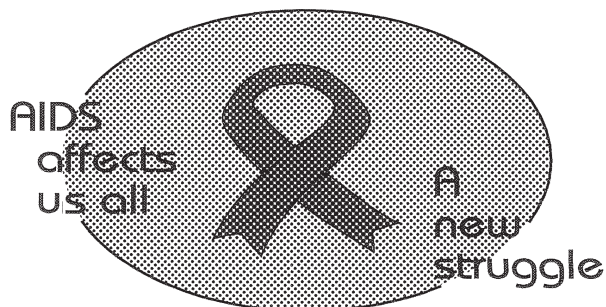

AMENDMENT IN TERMS OF SECTION 95(4) OF THE NORTH WEST LIQUOR
LICENSING ACT NO. 6 OF 2016 AND THE AMENDMENT ACT NO. 2 OF 2019**

I, Keobiditse Evelyn Bitsa Lenkopane, Member of the Executive Council responsible for the Department of Economic Development, Environment, Conservation and Tourism, do hereby declare in terms of Section 95(4) of the North West Liquor Licensing Act (No. 6 of 2016) that the lodgement of new applications in terms of the North West Liquor Licensing Act is not yet determined.

All the applications as contemplated by Act 27 of 1989 should be lodged in accordance with Act 27 of 1989 as if the same Act is still in place and be accompanied by a Designated Police Officers' report for the months of April, May, June, July and August 2025 or any other date which the Executive Authority may determine whichever comes first.

This proclamation will be of force and effect upon publication in the Gazette.
