If a file is not available in our Archives, the following arrangement is in place:

1. An affidavit needs to be made with the following info:
2. Why the file is not available in our Archives
3. The full history of the matter
4. Proof of slip that proves that request of file /s has been done, before the duplicate file can be opened in room 7.40

Closing time of Civil matters and time frame as to when files needs to be in room 7.40

According to the Directive issued from 30 October 2016:

1. Files needs to be drawn from our Archives at least 3-5 days before the Trial date.
2. The Roll closes at 12hoo 2 days prior to the hearing of the matter

The Clerks and the Messengers needs to draw the file well on time to have it indexed and paginated.

If the Clerks only do the drawing and indexing on the day that the Roll closes, the will not be ready by 12h00 noon.

It is strongly advisable to do it in the 5-3 day period before the closing of the Roll with in a period of 2 days at 12h00.
